To the Hanover Precinct Commissioners
and the Hanover Precinct Planning Board

We would like to express our interest in changing the zoning of those areas of Pine Park that lie within the precinct from General Residence-3, as now proposed, to Forestry and Recreation. This seems more in keeping with the foresighted purposes stated in the "Articles of Agreement" by the Pine Park Association upon its establishment in October 1905. We refer you to pages 71-73 Lord's History of Hanover.

We are requesting, also, that the strip of land running along the Connecticut River from the precinct line on the North to the mouth of Mink Brook on the South, and the areas along both sides of Mink Brook between the river and West Lebanon Road (also, between West Lebanon and Lebanon Road, if feasible) be changed from Rural Residence to Forestry and Recreation in the interests of the wildlife sanctuary, river bank conservation and green belt preservation.

We hope that the overwhelming public support of similar changes in the town zoning ordinance and map at the town meeting was adequate expression of community feeling.
